- A huge and heartfelt Thank-You for sending me to represent Central Section at the 2018 NAfME National Assembly and Leadership Conference in Washington DC.
  - Met with the staffs of eight Senators and Representatives for NAfME Hill Day on Thursday, June 28<sup>th</sup> with a nine member team from CMEA.
    - Lobbied for Part A of ESSA (Every Student Succeeds Act) under Title IV funding.
      - NAfME's asking was \$1.9 Billion for 2019

- 1. The proposal wording to allow judges to opt for a mileage stipend in lieu of a hotel night as long as it does not exceed \$125 (the allowable reimbursement for a hotel night. A person that lives in Clovis judging in Bakersfield would get about \$125 in mileage for one trip at 54.5 per mile) Someone coming from the Bay area or Southern California could get a mileage stipend or hotel reimbursement but not both.
- 2. A policy proposal that directors at large group festivals will turn into the Site Host a list of all participating performing students in case of a campus emergency.
- 3. Decide if we want to set a payment deadline for large group festivals to 6 weeks prior rather than 4 weeks prior. OR just say all payments are due by a certain date like January 15th for example.

# Legislative Report 8/20/1

## *Update of SB-933*

The bill provides onetime funding for "arts education." The June 27, 2018: Governor Brown signed the state budget for the coming year. Item 6100-134-0890, Provision 10, \$44,080,000, remains in the governor's budget. The \$44 million (Federal Title IV Funds) has been allocated to fund grants for enhancing visual and performing arts education or expanding access to physical and mental health care in schools by supporting school health centers. You can read the exact language in the final budget bill (Item 6100-134-0890, Provision 10). Sb 933 continues to move through the legislature. The bill is currently in the Assembly Appropriations Committee.

NAfME is thrilled to report the passage and long overdue reauthorization of the Carl D. Perkins Vocational and Technical Education Act (H.R 2353). The passage is a key victory for music education as this version of the Perkins Act includes mention of a well-rounded education (established by Sec. 8101 of ESEA). Through enactment of this law, school districts will need to provide detailed information on how they plan to incorporate a well-rounded education into their career and technical education plan.
